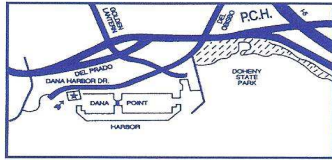

far left-hand lane. At second signal light turn left.
Follow Dana Point Harbor Drive to Ensenada Place.
Make U-turn into parking lot.



TRANSFERS:

If a student wishes to transfer to another date within the same class category the following applies:

1. Contact the office to check space availability in the class you wish to transfer to.
2. If space is available in the class, e-mail or phone in a transfer request to the office a minimum of (1) week prior to the start of the earliest class.
3. A transfer will be allowed (1) time, and must be completed within the current program season.

2. Every effort is made to be sure you are placed in the class of your choice. A registration receipt will be mailed to you within 2 weeks. The receipt will list the classes you are enrolled in. Please check the class(s) listed on your registration receipt carefully.
3. Class age restrictions are strictly enforced.
4. Students must pre-register for all programs unless noted otherwise in the class description. Classes will be canceled if the minimum enrollment is not met 3 days prior to the start of class. Some classes may sell out earlier than others.
5. There are no make-up sessions for missing a class. Make class selection carefully, you are responsible for reading and understanding the following refund and transfer policies.

REFUNDS:

Requests for refunds of program fees paid to Westwind Sailing must be submitted to Westwind Sailing by e mail westwind@westwindsailing.com a minimum of eight (8) days prior to the start of the program. No refunds will be given with less than 8 days notice. A \$50. processing fee per class will be deducted from all approved refunds. There are no refunds for 'no shows'.
